#### **RESOLUTION NO. 10-2021**

APPROVING RESOLUTION NO. 112-2020 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 FOR THE CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Burgos, Pangasinan submitted its Resolution No. 112-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Burgos, Pangasinan had identified items in their Supplemental Investment Program No. 5 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on November 10, 2020 by the Municipal Development Council through Resolution No. 2020-006;

**WHEREAS**, the Supplemental Investment Program No. 5 of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of programs/projects/activities of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P3,060,882.47. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 05-2020, which was passed and approved by their Sangguniang Bayan on November 20, 2020 thru Appropriation Ordinance No. 05, S-2020 and approved by the Municipal Mayor on November 26, 2020;
