DECLARING ORDINANCE NO. 18-02 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, **ENTITLED** "AN **ORDINANCE** SUPPLEMENTING ORDINANCE NO. 04-15 KNOWN AS "AN ORDINANCE ESTABLISHING SEPTAGE AND SEWAGE MANAGEMENT PROGRAM OF SAN CARLOS CITY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO **ENACT**

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 18-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the power of the Sangguniang Panlungsod to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;
