APPROVING SB RESOLUTION NO. 187-2019 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 06-2019 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF ONE MILLION NINE HUNDRED THOUSAND (P1,900,000.00) PESOS"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 187-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Malasiqui, Pangasinan has prepared the municipality's Supplemental Annual Investment Program No. 06 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 06-2019 dated November 22, 2018 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 187-2019 dated November 27, 2019;

WHEREAS, said Supplemental Annual Investment Program which has an investment of P1,900,000.00, covers augmentation funds for the MOOE of the Executive Department of the LGU;

WHEREAS, funding support for the Supplemental AIP is embodied in Supplemental Budget No. 4, FY 2019 of the LGU, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 004-2019 dated November 27, 2019;
