WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-060 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan prepared the City’s Supplemental Investment Program (SIP) No. 8 for CY 2020. This was endorsed by the Council thru CDC Resolution No. 08-20 (S-2020) dated September 4, 2020 to the Sangguniang Panlungsod for approval;

WHEREAS, the Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 20-060 dated September 7, 2020;
