DECLARING MUNICIPAL ORDINANCE NO. 5, S-2021 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “AN ORDINANCE CREATING SIXTEEN (16) POSITIONS UNDER THE FOLLOWING EXECUTIVE AND LEGISLATIVE OFFICES: 1. MAYOR’S OFFICE, 2. LDRRM OFFICE, 3. HR OFFICE, 4. BUDGET OFFICE, 5. ACCOUNTING OFFICE, 6. MUNICIPAL HEALTH OFFICE, 7. MSWD OFFICE, 8. ENGINEERING OFFICE AND SANGGUNIANG BAYAN OFFICE IN THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
