**RESOLUTION NO. 1006-2020**

**DECLARING ORDINANCE NO. 11-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING THE TITLE AND SECTION VII (PENALTY CLAUSE) OF SANGGUNIANG BAYAN ORDINANCE NO. 08-2020 OF SAN JACINTO, PANGASINAN APPROVED ON APRIL 7, 2020" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Ordinance No. 11-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160; Provincial Ordinance No. 240-2020 (Requiring the Mandatory Wearing of Face Mask by all Persons in Public Places Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Enhanced Community Quarantine and For Any Extension Thereof by adding a "No Contest Provision);

**WHEREAS**, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer in her opinion dated October 20, 2020;

**WHEREAS**, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
