REVIEWING MUNICIPAL ORDINANCE NO. 2021-10 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN ORDINANCE STRENGTHENING THE MUNICIPAL SCHOLARSHIP PROGRAM OF THE MUNICIPALITY OF MANGALDAN BY OPENING GRANTS TO STUDENTS IN COLLEGES/UNIVERSITIES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2021-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xi) of R.A. No. 7160;

WHEREAS, however, in the preparation of the Gender and Development Plan of the municipality, the scholarship grants to qualified students must be included and justification be specified why it will be charged to and can be attributed to GAD Budget, since the Philippine Commission on Women enumerated examples that can and cannot be charged to the GAD Budget, and scholarship fund is not included among those expenses allowed nor in the list of expenses not allowed to be charged/attributed to GAD;
