DECLARING ORDINANCE NO. 04-2021 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, **ENTITLED** ORDINANCE ESTABLISHING AND ADOPTING A SET OF AND **SYSTEMS ENSURING MEASURES SUPPLIES** COMMODITIES, DRUGS AND SERVICES WILL SUSTAINABLY BE PROVIDED FOR CURRENT AND FUTURE COMMODITIES, AND OTHER MATERNAL, NEONATAL, CHILD HEALTH AND NUTRITION (MNCHN) SERVICES IN THE MUNICIPALITY OF ROSALES, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**

No. 7160 and DOH Administrative Order No. 2010-0036;
