PROVINCIAL RESOLUTION NO. 1029-2020

INVITING THE PHILIPPINE STATISTICS AUTHORITY (PSA) THROUGH MR. EDGAR M. NORBERTE, CHIEF STATISTICAL SPECIALIST, TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON ITS DECEMBER 7, 2020 REGULAR (PHYSICAL) SESSION TO APPRISE THE BODY ON THE PLANS AND PROGRAMS BEING UNDERTAKEN BY THE AGENCY PARTICULARLY ON THE ESTABLISHMENT OF ITS FIELD OFFICES IN THE PROVINCE OF PANGASINAN

WHEREAS, the Philippine Statistics Authority (formerly National Statistics Office) is considered as one of the frontline services of the national government with the main function of planning, developing, prescribing, disseminating and enforcing policies, rules and regulations and coordinating government-wide programs governing the production of official statistics, general-purpose statistics, and civil registration services;

WHEREAS, the Province of Pangasinan comprises 44 municipalities and 3 cities but only one office of Philippine Statistics Authority is serving the whole Province and that is located in Calasiao;

WHEREAS, the Philippine Statistics Authority Calasiao is rendering service to hundreds of clients every working day coming from east to west parts of the Province, and the people are sometimes queueing in long lines and braving rains and heat of the sun to request for the issuance of birth certificate, marriage certificate, certificate of no marriage record (CENOMAR), death certificate and other documents;

WHEREAS, with the establishment of Philippine Statistics Authority Field Offices in the Province, it is the aim of the Provincial Government to improve the welfare and needed services of the people in terms of saving time and resources in going to and from the Municipality of Calasiao;

WHEREAS, the Sangguniang Panlalawigan would like to be informed of the plans and programs being undertaken by the Philippine Statistics Authority, in aid of legislation;

WHEREFORE, on motion of SP Member Rosary Gracia P. Perez-Tababa, duly seconded, it was –


