PROVINCIAL ORDINANCE NO. 103-2003

AN ORDINANCE TRANSFERRING THREE (3) PLANTILLA POSITIONS FROM EASTERN PANGASINAN DISTRICT HOSPITAL TO PANGASINAN PROVINCIAL HOSPITAL, SAN CARLOS CITY AND APPROPRIATING FUNDS THEREFOR

BE IT ENACTED by the Sangguniang Panlalawigan of Pangasinan in session assembled that:

Section 1. There is hereby transferred the following plantilla positions from Eastern Pangasinan District Hospital in Tayug, Pangasinan to Pangasinan Provincial Hospital in San Carlos City, Pangasinan:

Section 2. The positions enumerated in Section I of this Ordinance shall augment the existing manpower of the Pangasinan Provincial Hospital, San Carlos City and in the interest of a more efficient and effective health services.

Section 3. The appropriation for the salaries and other remuneration of the two (2) Medical Officers III and one (1) Nurse III shall be transferred from the Eastern Pangasinan District Hospital to the Pangasinan Provincial Hospital, San Carlos City.
