PROVINCIAL RESOLUTION NO. 1031-2020

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT – I FOR THE IMPLEMENTATION OF THE HEALTH FACILITIES ENHANCEMENT PROGRAM IN THE PROVINCE OF PANGASINAN THROUGH THE CONSTRUCTION OF AN ISOLATION FACILITY IN THE PANGASINAN PROVINCIAL HOSPITAL, SAN CARLOS CITY, PANGASINAN

WHEREAS, the Health Facilities Enhancement Program (HFEP) is a Department of Health (DOH) program that aims to improve and upgrade health facilities in order to sufficiently provide emergency and primary health care services to the people;

WHEREAS, the HFEP's budget has been allocated for infrastructure projects for local government units and the Province of Pangasinan is one of the beneficiaries;

WHEREAS, the Department of Health, through the HFEP 2020, has appropriated the amount of P10,000,000.00 for the Construction of an Isolation Facility at the Pangasinan Provincial Hospital, San Carlos City, Pangasinan to be implemented by the Provincial Government of Pangasinan through the transfer of funds;

WHEREAS, the Project is very timely during this period of public health crisis as a means to further contain the spread of COVID-19 in the Province;

WHEREAS, the Province of Pangasinan fully supports the Program and is capable of implementing the Project under it;

WHEREAS, for the above purpose, the Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and the Department of Health – Center for Health Development-I, represented by Dr. Valeriano Jesus V. Lopez, Regional Director;
