## **RESOLUTION NO. 1042-2021**

**DECLARING MUNICIPAL ORDINANCE NO. 2021-002 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A LAND COVERED BY TAX DECLARATION NO. 41-0006-06206 WITH AN AREA OF TWENTY-FIVE THOUSAND ONE HUNDRED (25,100) SQUARE METERS LOCATED IN BARANGAY AMISTAD, TAYUG, PANGASINAN FROM AGRICULTURAL LAND USE INTO COMMERCIAL LAND USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2021-002 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

**WHEREAS**, the Municipality of Tayug has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan 2016-2025, wherein said parcel of land is classified as agricultural under the agricultural zone;


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2021-002 of the Sangguniang Bayan of Tayug, Pangasinan, entitled” An Ordinance reclassifying a land covered by Tax Declaration No. 41-0006-06206 with an area of Twenty-Five Thousand One Hundred (25,100) Square Meters located in Barangay Amistad, Tayug, Pangasinan from agricultural land use into commercial use” as within the conferred powers of the Sangguniang Bayan to enact;
