APPROVING RESOLUTION NO. 2020-86 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2020-06 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2020-86 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Binalonan, Pangasinan has formulated and endorsed the municipality’s Supplemental Investment Program No. 06 thru MDC Executive Committee Resolution No. 05, S-2020, S-2020 dated October 9, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on October 12, 2020 thru Resolution No. 2020-86;

WHEREAS, the said Supplemental Investment Program No. 06 with an investment requirement of P9,893,867.00 covers the implementation of salary increase, and other personnel benefits of municipal officials and employees, and the construction of Slope Protection at Sitio Lubas, Sta. Catalina;

WHEREAS, the Sangguniang Bayan on October 12, 2020 enacted Supplemental Budget No. 2 CY 2020 thru Appropriation Ordinance No. 2020-02 to support the implementation of the Supplemental Investment Program of the municipality;
