APPROVING RESOLUTION NO. 57-2021 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 CY 2021 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto Pangasinan submitted its SB Resolution No. 57-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Municipal Development Council of San Jacinto, Pangasinan has prepared the municipality's Supplemental Investment Program No. 2 for CY 2021. This was endorsed by the Council through Resolution No. 2021-2 dated August 23, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the proposed Supplemental Investment Program with an investment requirement of P38,972,928.94 covers augmentation funds for Personal Services, MOOE, and Capital Outlay, and implementation of COVID-19-related PPAs, LDRRM projects/activities and development projects of the LGU;
