APPROVING RESOLUTION NO. 109-2020 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL NO. 7 OF THE ANNUAL INVESTMENT PROGRAM (AIP), CALENDAR YEAR 2020 OF THE MUNICIPALITY OF AGNO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Resolution No. 109-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Agno, Pangasinan had identified items in their Supplemental Investment Program No. 7 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on October 1, 2020 by the Municipal Development Council through Executive Committee Resolution No. 07-2020 and was favorably acted upon by the Sangguniang Bayan on October 12, 2020, 2020 thru SB Resolution No. 109-2020;

WHEREAS, the Supplemental Investment Program No. 7 of the municipality covers the granting of Hazard Pay to municipal officials and employees and fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of projects and of some municipal offices;
