#### **RESOLUTION NO. 106-2022**

APPROVING SB RESOLUTION NO. 176, S-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "APPROVING THE 2<sup>ND</sup> SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 176, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS,** the Municipal Development Council of Manaoag, Pangasinan prepared the municipality's 2<sup>nd</sup> Supplemental Investment Program for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 29, 2021 through MDC Resolution No. 02, Series of 2021;

WHEREAS, said Supplemental Investment Program (SIP) has a total investment requirement of P39,360,201.66. Of this, the sum of P37, 560,201.66 will be financed from the General Fund and Tobacco Excise Tax share of the LGU as per DBM's Local Budget Memorandum Nos. 82-2021 & 84-2021. The remaining balance of P1,800,000.00 will be derived from the Trust Fund/Tobacco Excise Tax as per DBM's Local Budget Memorandum No. 81-2021. The proposed projects to be funded from the Tobacco Excise Tax are based on R.A. No. 8240 and the aforementioned Local Budget Memoranda of the DBM;

**WHEREAS,** funding for the SIP is embodied in the LGU's Supplemental Budget No. 02, CY 2021, which was approved by the Sangguniang Bayan through Appropriation Ordinance No. 03, Series of 2021 on December 14, 2021;
