**APPROVING RESOLUTION NO. 20-066 OF THE SANGGUNIANG** PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED **"REALIGNING THE AMOUNT OF TWO MILLION ONE HUNDRED** EIGHTY THOUSAND FIFTY NINE PESOS (P2,180,059.00) FROM THE PROJECT TITLED: 1) LOT PURCHASE FOR THE CONSTRUCTION OF MULTI-PURPOSE HALL AT BARANGAY GAMATA (P1,116,806.00), 2) LIVELIHOOD & ENTREPRENEUR PROGRAM (P1,000,000.00) DEVELOPMENT AND 3) **REHABILITATION OF SLAUGHTERHOUSE (P63,253.00) TO PROJECTS TITLED: 1) INSTALLATION OF SOLAR STREET** LIGHTS AT BARANGAY GAMATA (PHASE II) AMOUNTING TO P2,000,000.00, AND 2) REHABILITATION OF LIVESTOCK (ADDITIONAL) AMOUNTING TO MARKET PHASE Ш P180,059.00"

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-066 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City has proposed to the Sangguniang Panlungsod the realignment of the sum of P P2,180,059.00 from the 20% Development Fund CY 2020 to finance the implementation of proposed priority projects of the City of San Carlos. This was endorsed by the Council, through CDC Resolution No. 11-20 (S-2020) dated September 16, 2020 to the Sangguniang Panlungsod for approval;
