**APPROVING RESOLUTION NO. 2021-134 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4, CY 2021 OF SUAL, PANGASINAN AMOUNTING TO THREE MILLION FOUR HUNDRED THIRTY THOUSAND SEVEN HUNDRED FORTY & 38/100 PESOS (P3,430,740.38)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2021-134 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

**WHEREAS**, the Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on October 6, 2021 through MDC Executive Committee Resolution No. 2, series of 2021;

**WHEREAS**, the said Supplemental Investment Program of the municipality covers the project Purchase of Lot for Poblacion Cemetery-Phase I;
