APPROVING RESOLUTION NO. 221-121819 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE THIRD SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FOR CY 2019 FUNDED BY THE LGU’S UNAPPROPRIATED BALANCE (SURPLUS, SAVINGS AND REVERSION) FROM ITS PREVIOUS YEAR OF OPERATION”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 221-121819 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality’s 3rd Supplemental Investment Program for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 03, S-2019 dated December 13, 2019. The Sangguniang Bayan approved the 3rd Supplemental Investment Program on December 18, 2019 thru Resolution No. 221-121819. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the 3rd Supplemental Investment Program of the municipality with an investment requirement of P1,533,025.00 covers the fund augmentation for personal services of offices in the municipality;

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan has enacted Supplemental Budget No. 3 through Appropriation Ordinance No. 03-121819 dated December 18, 2019 to support the implementation of the programs/projects embodied in the 3rd Supplemental Investment Program of the municipality;
