APPROVING RESOLUTION NO. 2021-552 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 4, FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its SB Resolution No. 2021-552 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Balungao, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 4 through MDC Resolution No. 2021-08 dated October 28, 2021 to their Sangguniang bayan for approval;

WHEREAS, the Supplemental Investment Program No. 4 with an investment requirement amounting to Php 12,942,057.85 covers the implementation of development projects and fund augmentation for disaster risk reduction and management activities maintenance and other operating expenses and capital outlay of offices in the LGU;

WHEREAS, on November 3, 2021, the Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 2021-03 to support the implementation of the Supplemental Investment Program No. 3 of the municipality;
