## PROVINCIAL RESOLUTION NO. 11-2019

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO SIGN A DEED OF DONATION AND ACCEPT A 4,000-SQUARE METER LOT COVERED BY CERTIFICATE OF TITLE NO. T-52567 IN ASINGAN, PANGASINAN AS A SITE FOR THE LOCATION OF THE ASINGAN COMMUNITY HOSPITAL**

**WHEREAS**, Spouses Editha C. Ginez and Fidel D. Ginez are the owners of a parcel of land situated at Barangay Dupac, Municipality of Asingan, Province of Pangasinan, consisting an area of 4,000 square meters, covered by Certificate of Title No. T-52567 of the Register of Deeds of the Municipality of Tayug, Pangasinan with Tax Declaration No. 19390;

**WHEREAS**, in 1990s, Spouses Editha C. Ginez and Fidel D. Ginez executed a Conditional Deed of Donation over a portion of the said real property for the exclusive purpose of building and operating a hospital thereat with the condition that the property shall revert back to the donors should the hospital operation stop or discontinue;

**WHEREAS**, the Asingan Community Hospital has been built within the subject premises and as of the present, the Province of Pangasinan operates and funds the facility in accordance with generally accepted guidelines and policies, and continues to upgrade the medical services being provided thereat;

**WHEREAS**, Mrs. Editha C. Ginez, with marital consent of her husband, Fidel D. Ginez, are voluntarily and freely giving, transferring and conveying, by way of Deed of Donation in a manner that is absolute, the 4,000 square meters lot to the Province of Pangasinan;
