APPROVING RESOLUTION 95, S-2020 NO. **OF** THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, "APPROVING **ENTITLED** THE ANNUAL **INVESTMENT** PROGRAM (AIP) OF THE LOCAL GOVERNMENT UNIT OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2021"

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 95, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that it is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Sto. Tomas, Pangasinan had formulated the municipality's Annual Investment Program for Calendar Year 2021 and endorsed thru MDC Resolution No. 05-SS-2021 dated November 6, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Sto. Tomas, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other services sectors and covers: a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects and activities. It also includes the following: 1) Local Climate Change Action Plan, Peace and Order Plan, and Gender and Development Plan, 2) list of programs/projects/activities to promote Local Tourism, for Senior Citizens and Persons with Disabilities, for the Protection of Children, and to combat AIDS;

WHEREAS, the proposed AIP of Sto. Tomas for CY 2021 has a total investment requirement of P75,076,493.00. Funding support for the implementation of which is embodied in their proposed Annual Budget for CY 2021, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 5, S-2020 dated December 15, 2020;

WHEREAS, the development fund amounting to P14,392,298.60 which is allocated for development projects is 20% of the LGU's IRA (P71,961,493.00) for CY 2021. This is in accordance with Section 287 of RA 7160

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs/projects/activities identified to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P3,753,824.65 were based on Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, the LDRRM Plan of the municipality shall be submitted to the Office of Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management – Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the LGU of Sto. Tomas had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and were found to be fully compliant in form and in contents with the provisions of Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated December 11, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
