**RESOLUTION NO. 1114-2021**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 7 FOR CALENDAR YEAR 2019-22 OF THE CITY OF URDANETA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P40,995,000.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Supplemental Budget No. 7 for CY 2019-22 involving total appropriations of P40,995,000.00, which was enacted on September 21, 2021 through Appropriation Ordinance No.57, Series of 2019-22;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the appropriation for Other Maintenance and Operating Expenses shall cover only other expenses not otherwise classified under any of the specific maintenance and other operating expense accounts, in accordance with the Revised Chart of Accounts for LGU's under COA Circular No. 2015-009 dated December 1, 20215;
3. That all programs, projects and activities to be implemented are in accordance with the CY 2021 Supplemental Investment Program of the city; and
4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations.


**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the city;


