APPROVING RESOLUTION NO. 2020-54 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 CY 2020, AS EMBODIED IN THE MDC RESOLUTION NUMBER 5, SERIES OF 2020 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2020-54 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bolinao, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on October 2, 2020 by the Municipal Development Council through MDC Resolution No. 5, S-2020 and was favorably acted upon by the Sangguniang Bayan on October 15, 2020 thru SB Resolution No. 2020-54;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, implementation of disaster risk reduction and management projects and gender and development programs;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P20,605,422.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 4 for Calendar Year 2020, which was passed and approved by their Sangguniang Bayan thru Appropriation Ordinance No. 2020-04 on October 15, 2020 in the amount of P12,622,422.00. The remaining P7,983,000.00 will be funded from the Local Government Support Fund – Assistance to Municipalities;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
