APPROVING RESOLUTION NO. 111, S-2019 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE LOCAL GOVERNMENT UNIT OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2020"

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 111, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sto. Tomas, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 04-SS-2019 dated December 5, 2019. The Sangguniang Bayan approved the Annual Investment Program on December 20, 2019 thru Resolution No. 111, S-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-1 dated August 7, 2014 as amended by DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP of Sto. Tomas, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary items for the operation of the different

municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Management Programs/Projects/Activities of the municipality. It also includes the following: a) Gender and Development Plan, Local Climate Change Action Plan, Peace and Order Plan, and 2) list of programs, projects and activities to promote Local Tourism; for Senior Citizens and Persons with Disabilities; for the Protection of Children, and to Combat Acquired Immune Deficiency Syndrome (AIDS);

WHEREAS, the AIP of Sto. Tomas for CY 2020 has a total investment requirement of P85,660,735.13. The amount of P71,037,735.13 is supported by 2020 proposed Annual Budget of the municipality which was passed and approved by the Sangguniang Bayan on December 20, 2019 through Appropriation Ordinance No. 04, S-2019 while the remaining amount of P14,623,000.00 will be funded by the national government under LGSF-Financial Assistance/Assistance to Municipalities Program;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. The development fund amounting to P13,485,564.20 which is allocated for development projects is twenty percent (20%) of the LGU's IRA (P67,427,821.00) for CY 2020;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs/projects/activities identified to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P3,551,891.05 conforms with Section 21 of RA 10121and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013(Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The LDRRM Plan of the municipality shall be submitted to the Office of Civil Defense for review as provided under Item 2.2.12 of the Department of Budget and Management-Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the LGU of Sto. Tomas has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
