**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 269, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;
