RESOLUTION NO. 1139-2020

DECLARING ORDINANCE NO. 28-2020 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING PUBLIC COMMUTERS AND DRIVERS, AND EMPLOYEES OF BOTH GOVERNMENT AND PRIVATE OFFICES INCLUDING COMMERCIAL ESTABLISHMENTS TO WEAR FACE SHIELD ALONG WITH FACEMASK WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SUAL, PANGASINAN DURING THE PERIOD OF COMMUNITY QUARANTINE OR UNTIL LIFTED, AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 28-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public); Section 8 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, however, the Sanggunian shall consider the points raised by the Provincial Legal Officer in her opinion dated November 26, 2020;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 28-2020 of the Sangguniang Bayan of **Sual**, Pangasinan, entitled "An Ordinance requiring public commuters and drivers, and employees of both government and private offices including commercial establishments to wear face shield along with facemask within the territorial jurisdiction of the Municipality of Sual, Pangasinan during the period of community quarantine or until lifted, and providing penalties for violation thereof" as within the conferred powers of the Sangguniang Bayan to enact;
