RESOLUTION NO. 1144-2020

APPROVING RESOLUTION NO. 38, S-2020 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN FY-2021 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 38, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out is in consonance to Sections 106, 109 and 114 of RA 7160. The Municipal Development Council of Mapandan, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 03, S-2020 dated September 21, 2020 and was favorably acted upon by the Sangguniang Bayan through SB Resolution No. 38, S-2020 dated October 19, 2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Mapandan, Pangasinan has prepared using the the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Local Disaster Risk Reduction and Management Programs/Projects/Activities, and d) Activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) Peace and Order Plan, b) List of Programs, Projects/Activities (PPAs) for the Local Council for the Protection of Children, and c) List of PPAs for Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP of Mapandan for CY 2021 has a total investment requirement amounting to P129,281,542.00. This will be financed by the LGU as embodied in their 2021 Annual Budget passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 03, S-2020 dated October 19, 2020;

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P116,851,792.00), amounting to P23,370,358.40 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the 5% Local Disaster Risk Reduction and Management Investment Plan/Program, amounting to P6,207,077.10, were already reviewed by Office of the Civil Defense-Regional Office I as part of their Six-Year LDRRM Plan (2020-2025) and the LGU was advised to consider to adopt the necessary amendments to the Plan and submit the revised Plan to the OCD-RO1;

WHEREAS, the Gender and Development Plan and Budget for CY 2019 of the municipality has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 38, S-2020 of the Sangguniang Bayan of **Mapandan**, Pangasinan, entitled "Approving the Annual Investment Plan FY-2021 of the Municipality of Mapandan, Province of Pangasinan";
