PROVINCIAL ORDINANCE NO. 115-2005

AN ORDINANCE ABOLISHING SIX (6) POSITIONS OF SANITATION INSPECTOR I UNDER THE OFFICE OF THE PROVINCIAL HEALTH OFFICER AND CREATING TWO (2) MEDICAL OFFICER III AND ONE (1) NURSE I FOR ASINGAN MEDICARE HOSPITAL AND BOLINAO MEDICARE HOSPITAL

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (1) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, the positions of Sanitation Inspector, item nos. 59, 74, 85, 88, 90 and 101 in the Office of the Provincial Health Officer are vacant;

WHEREAS, there is a need to abolish these positions and create two (2) Medical Officer III and one (1) Nurse I for Asingan Medicare Hospital and Bolinao Medicare Hospital to augment their existing workforce;

WHEREAS, the appropriation for salaries and other benefits of the abolished positions will be used for the salaries and other benefits of the three (3) new positions and that there will be no increase in appropriation for personal services;

WHEREFORE, on motion of SP Members Angel G. Baniqued and Romeo H. Dadacay, duly seconded –

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. The positions of two (2) Medical Officer III, Grade 18, and Nurse I, Grade 10, shall be created under the Asingan Medicare Hospital and Bolinao Medicare Hospital in lieu of the abolition of six (6) <u>Sanitation Inspector I</u>, item nos. 59, 74, 85, 88, 90 and 101 under the Office of the Provincial Health Officer.

SECTION 2. The two (2) new positions shall have the following duties and responsibilities:

Medical Officer III

- 1. Examines patients and diagnoses ailments; treats diseases by prescribing medications and other therapeutic means.
- 2. Prepares clinical records of patients upon admission and discharge.
- 3. Is responsible for one or more wards and makes daily rounds to observe progress and conditions of patients.
- 4. Attends to and participates in clinical pathological conferences.
- 5. Consults supervisors on difficult and complicated cases.

Nurse I

- 1. Assists in treating patients in PHO clinic and during conduction of medical/dental missions (KSB).
- 2. Monitors and evaluates the implementation of the different health programs/projects in the province.
- 3. Assists in the development of plans, programs and standards in nursing for implementation by the PHO.
- 4. Coordinates activities of nursing personnel in consonance of established policies and guidelines for the improvement of health services.

- 5. Assists in the conduct of training programs as may be necessary for the improvement of health services.
- 6. Participates in staff conferences, meetings, seminars and workshops.
- 7. Provides technical assistance to RHMs/BHWs.
- 8. Prepares records/reports on health programs/projects.

SECTION 3. The corresponding salaries of two (2) Medical Officer III and one (1) Nurse I which are P190,092.00 and P119,268.00 per annum shall be provided in Supplemental Budget No. 1 of the General Fund of the Province for CY 2005 and be included in the plantilla of personnel.

SECTION 4. Effectivity. This Ordinance shall take effect on September 1, 2005.
