## **PROVINCIAL RESOLUTION NO. 12-2019**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A DISPOSAL AGREEMENT WITH METRO CLARK WASTE MANAGEMENT CORPORATION FOR THE DISPOSAL OF THE PROVINCE'S RESIDUAL WASTE AT METRO CLARK SANITARY LANDFILL FACILITY FOR THE PURPOSE OF ITS RENEWAL**

**WHEREAS**, RA No. 7160, otherwise known as the Local Government Code of 1991, has vested upon local government units, the authority to prescribe regulations aimed at the promotion and preservation of public health, order, safety and general welfare of its inhabitants;

**WHEREAS**, the Province of Pangasinan continuously generates, recycles and hauls residual solid wastes and is in need of a sanitary landfill facility as final disposal for such residual solid wastes from households and business establishments;

**WHEREAS**, Metro Clark Waste Management Corporation (MCWMC), manages and operates an Engineered Sanitary Landfill in accordance with Republic Act 9003 at the Clark Integrated Waste Management Center located at Subzone D, Clark Special Economic Zone, where all collected residual wastes from the Province will be transported and disposed;

**WHEREAS**, the Disposal Agreement for 2018 entered into by the Province has already lapsed and there is a need to renew the same for the continuous partnership of the Province with Metro Clark Waste Management Corporation;


