APPROVING RESOLUTION NO. 81, S-2020 OF THE SANGGUNIAN BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 03, CY 2020 OF THE LOCAL GOVERNMENT UNIT, DASOL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Resolution No. 81, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Dasol, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on November 6, 2020 by the Municipal Development Council through MDC Executive Committee Resolution No. 4, S-2020;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality covers fund augmentation for the Personal Services (Performance Enhancement Incentive), Maintenance and Other Operating Expenses and Capital Outlay of municipal offices and implementation of programs to address the impact of Covid-19 and other development projects of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P7,107,788.30. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 03 for Calendar Year 2020, which was passed and approved by their Sangguniang Bayan on November 20, 2020 thru Appropriation Ordinance No. 169 on November 24, 2020 and approved by the Municipal Mayor on December 1, 2020;


