RESOLUTION NO. 122-2022

DECLARING ORDINANCE NO. 12, S-2021 OF THE SANGGUNIANG OF SAN QUINTIN, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION OF ONE (1) ENGINEER I – SALARY GRADE 12 IN THE OFFICE OF THE MUNICIPAL ENGINEER IN THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Ordinance No. 12, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, however, the qualifications of the new positions as contained in Qualification Standards issued by the Civil Service Commission should be included in the ordinance;
