PROVINCIAL RESOLUTION NO. 125-2022

URGING ALL LOCAL GOVERNMENT UNITS OF THE PROVINCE OF PANGASINAN TO FURTHER INTENSIFY AND CONTINUE WITH THEIR CAMPAIGN FOR COVID-19 VACCINATION IN THEIR AREAS OF RESPONSIBILITY

WHEREAS, the highly transmissible Omicron variant of COVID-19 is driving an unprecedented surge of infections globally;

WHEREAS, Metro Manila and several provinces all over the country have already been placed under the stricter Alert Level 3 due to the spike of COVID-19 cases and the detection of cases of the highly infectious Omicron variant;

WHEREAS, the Province of Pangasinan is also experiencing an increase on the average number of COVID-19 cases for the past days;

WHEREAS, during this period of public health crisis, local government units are always in the forefront of the battle to further curb the transmission of COVID-19;

WHEREAS, local government units play vital roles in addressing and managing the crisis and in ensuring the implementation of COVID-19 vaccination program which is proven to be effective to protect the people;

WHEREAS, there is a need to facilitate an intensified and continuous provincewide program for the people to understand its benefits and to build trust for the vaccine and routine immunization;
