AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU (DENR-EMB) FOR THE IMPLEMENTATION OF THE PROJECT FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF SOLID WASTE MANAGEMENT EQUIPMENT CONSISTING OF BRAND-NEW SET OF PLASTIC RECYCLING EQUIPMENT WITH BRAND NEW PLASTIC CHAIR MOLDS
