PROVINCIAL ORDINANCE NO. 131-2007

AN ORDINANCE ESTABLISHING THE PROVINCIAL HEALTH CLINIC AND LABORATORY AT LINGAYEN, PANGASINAN

WHEREAS, one of the main thrusts of the provincial government is to provide basic health care and services and to plan programs related to health activities for the benefit and welfare of the people of this province;

WHEREAS, it is the objective of this Province to put-up a Provincial Health Clinic and Laboratory to be located at the Capitol Compound of Lingayen, Pangasinan, a place which is viable to the people since it is the seat or center of the provincial government;

WHEREAS, the Provincial Health Clinic and Laboratory aims to provide dental, drug testing and water analysis services to Pangasinenses at reasonable and affordable costs;

WHEREAS, the Provincial Health Office possesses the technical, physical and personnel capabilities to operate dental, drug testing and water analysis facilities for the Province;

WHEREFORE, in view of the foregoing, on motion of SP Member Dionisio A. Villar, Jr., duly seconded –

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

Section 1. This ordinance shall establish the Provincial Health Clinic and Laboratory, under the administration of the Provincial Health Office, to be located at the old NFA Building, Capitol Compound, Lingayen, Pangasinan.

Section 2. The Provincial Health Clinic and Laboratory shall aim to deliver health programs and activities responding and responsive to the basic health care and needs of the people of this Province.

Section 3. The Provincial Health Clinic and Laboratory shall have the following facilities and functions, to wit:

1. Dental Clinic – a clinic equipped with dental unit with high-speed chair with hand piece, compressor and hand instruments. The Provincial Dental clinic offers tooth extraction, oral prophylaxis and permanent and temporary filling.
2. Drug Testing Unit – a laboratory area or place fully equipped with equipment, reagents and personnel performing drug test and accredited by the Dangerous Drugs Board.
3. Water Analysis Laboratory – a laboratory area or place that will perform water analysis examination and other routine laboratory procedures. Likewise, it will perform enteric bacteriology examinations to enable isolate cholera organism, salmonella typhi and other water borne diseases.

Section 4. The above-facilities shall compose the following personnel:

Dental Clinic

1. Dentist – the Provincial Health Office has two (2) regular dentists.
2. Dental Aide – the Provincial Health Office has one (1) dental aide.

Drug Testing Unit **(Screening Laboratory)**

1. Head of the Laboratory
 - a) A licensed physician certified in Clinical Pathology by the Philippine Board of Pathology; or
 - b) A license physician trained in laboratory management and drug testing operation.
2. Analyst must be a registered;
 - a) Chemist
 - b) Chemical engineer
 - c) Medical Technologist
 - d) Pharmacist


3. Authorized specimen collector – to collect the specimen and must undergone appropriate training.

Water Analysis Laboratory


1. Pathologist – Board certified Pathologist of Region I Medical Center can be designated as a visiting Pathologist, contractual or regular plantilla position. (Complied)
2. Medical Officer – a Medical Doctor of the Provincial Health Office (PHO) to supervise the operations of the water analysis laboratory. (complied)
3. Sanitary Engineer – Sanitary Engineer from CHD-Region I can be designated as visiting Sanitary Engineer. (Complied)
4. Medical Technologist – the PHO has five (5) regular Medical Technologists and one (1) casual. (Complied)
5. Administrative Clerk – in-charge of the administrative functions at the same time a data encoder. (Complied)
6. Utility Worker – a full-time utility worker to maintain the cleanliness of the laboratory and to help in washing laboratory equipment and glass wares. (Complied)

Section 5. The provincial government of Pangasinan shall appropriate funds therefore, which shall be used for the maintenance, operation and other purposes of the clinic.

Section 6. This ordinance shall take effect immediately upon its approval.
