RESOLUTION NO. 134-2019

DECLARING MUNICIPAL ORDINANCE NO. 18-004 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING CHAPTER I SECTION 1 ARTICLES 2 AND 3, CHAPTER II SECTIONS 3, 4 AND 6, ARTICLES 12 (A) (E) AND 14, 22, 23 (F), 42 (A) (D), 43 (A), 48 (C), AND 51, AND CHAPTER III SECTIONS 7 AND 8 ARTICLES 85 AND 92 OF MUNICIPAL ORDINANCE NO. 6 SERIES OF 2007, OTHERWISE KNOWN AS "AN ORDINANCE PROVIDING A COMPREHENSIVE CHILDREN AND FAMILY SUPPORT SYSTEM IN THE MUNICIPALITY OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 18-004 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xiv) of RA 7160; Section 3 (2) Article XV of the Philippine Constitution; Section 2 of RA 7160 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act);

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 18-004 of the Sangguniang Bayan of **Laoac**, Pangasinan, entitled “An Ordinance amending Chapter I Section 1 Articles 2 and 3, Chapter II Sections 3, 4 and 6 Articles 12 (A) (E) and 14, 22, 23 (F), 42 (A) (D), 43 (A), 48 (C), and 51, and Chapter III Sections 7 and 8 Articles 85 and 92 of Municipal Ordinance No. 6, Series of 2007, otherwise known as “An Ordinance Providing a Comprehensive Children and Family Support System in the Municipality of Laoac, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
