RESOLUTION 464. S-2020 **OF** THE APPROVING NO. BINMALEY, **SANGGUNIANG** BAYAN OF PANGASINAN. ENTITLED "APPROVING THE 2020 **SUPPLEMENTAL** INVESTMENT PROGRAM NO. 9 FOR CY 2020 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 464, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 9 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on December 23, 2020 by the Municipal Development Council through Executive Committee Resolution No. 7, S-2020;

WHEREAS, the Supplemental Investment Program No. 9 of the municipality covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to municipal officials and employees) and Maintenance and Other Operating Expenses under the Executive Services;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P1,633,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 9, CY 2020, which was enacted by their Sangguniang Bayan on December 28, 2020 through Appropriation Ordinance No. 10, S-2020;
