APPROVING RESOLUTION NO. 309-12302021 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE FIFTH SUPPLEMENTAL INVESTMENT PROGRAM FOR CY 2021 FUNDED FROM SHARES FROM TOBACCO EXCISE TAX, UNAPPROPRIATED BALANCE OF PREVIOUS SUPPLEMENTAL BUDGET, AND REVERSION OF APPROPRIATION FOR UNFILLED POSITIONS OF POZORRUBIO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 309-12302021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Pozorrubio, Pangasinan had identified items in their Fifth Supplemental Annual Investment Program for CY 2021. This was endorsed to the Sangguniang Bayan for approval on December 28, 2021 through MDC Resolution No. 06, Series of 2021;

WHEREAS, the Fifth Supplemental Investment Program of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and implementation of development programs/projects/activities of the LGU;

WHEREAS, to support the implementation of the Fifth Supplemental Investment Program, which has a total investment requirement of Php3,330,016.00, the Sangguniang Bayan enacted Supplemental Budget No. 5 on December 30, 2021 through Appropriation Ordinance No. 06-12302021;

WHEREAS, the identified project to be funded from the municipality's CY 2018 share from Tobacco Excise Tax, which has an investment requirement of Php725,016.00 is consistent with Local Budget Memorandum Nos. 83 and 84 dated November 22, 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—
