**APPROVING RESOLUTION NO. 220, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 6 FOR CY 2020 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN AMOUNTING TO P1,556,967.00"**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 220, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Fabian, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 6 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 07, S-2020 dated October 19, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, said Supplemental AIP, which has a total investment requirement of P1,556,967.00, covers the implementation of LGU proposed projects to be sourced from the realignment/reversion of funds appropriated to the following projects, to wit:

**WHEREAS**, the new proposed project to be funded by the 20% Development Fund (reversion) conforms with DILG and DBM Joint Memo-Circular No. 2017-1 dated February 22, 2017 (Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects) and DILG and DBM Joint Circular No. 01 dated March 27, 2020 (Additional Guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects in view of the Coronavirus Disease 2019 (COVID-19) Situation);

**WHEREAS**, for the GAD-funded project, the proposed realignment or amendment to the LGU's GAD Plan and Budget for CY 2020 shall be forwarded to the DILG-Provincial Office for their review as per provisions of JMC 2016-01 (*Amendments to JMC 2013-01 or the Guidelines on the Localization of the Magna Carta of Women*), particularly Section 4.1.C.7 (*Implementation and Monitoring of the LGU GAD Plan and Budget*);

**WHEREAS**, funding for the Supplemental AIP is embodied in their Supplemental Budget No. 5, CY 2020, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 5, S-2020 dated December 9, 2020;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian;


