APPROVING MUNICIPAL RESOLUTION NO. 135-2019 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 02, S-2019 OF ANDA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 135-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2019 with a total investment requirement of P2,485,000.00. This was endorsed to the Sangguniang Bayan for approval on December 11, 2019 thru MDC Resolution No. 04, S-2019 and was favorably acted upon by the Sangguniang Bayan on December 11, 2019 thru SB Resolution No. 135-2019;

WHEREAS, the Supplemental Investment Program No. 2 for CY 2019 of the municipality covers the fund augmentation for the personal services of all the offices municipality;

WHEREAS, funding for the full implementation of this Supplemental Investment Program is embodied in their proposed Supplemental Budget No. 02 Calendar Year 2019 which was approved and enacted by their Sangguniang Bayan on December 11, 2019 thru Appropriation Ordinance No. 03, S-2019;
