APPROVING RESOLUTION NO. 226-12312020 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE FIFTH SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2020 FUNDED FROM REVERSION OF APPROPRIATION OF UNFILLED POSITIONS OF POZORRUBIO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 226-12312020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality's Fifth Supplemental Investment Program and endorsed through MDC Resolution No. 05, S-2020 dated December 29, 2020 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Fifth Supplemental Investment Program with an investment requirement amounting to P478,500.00 covers the grant of gratuity pay to contract of service and job order workers in the municipality;

WHEREAS, on December 31, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 5 through Appropriation Ordinance No. 07-12312020 to support the implementation of the Supplemental Investment Program No. 5 of the municipality;
