APPROVING RESOLUTION NO. 220-12142020 OF THE SANGGUNANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FOR CY 2021 FUNDED BY THE GENERAL FUND, 20% DEVELOPMENT FUND, 5% CALAMITY (LDRRM) FUND OF THE LGU"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 220-12142020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2020 and endorsed through MDC Resolution No. 03, S-2020 dated September 21, 2020 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Pozorrubio, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other services sectors and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS),

Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Municipal Nutrition Action Plan, Annual Cultural Development Plan, and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, to address the problem on illegal drugs and to combat Acquired Immune Deficiency Syndrome;

WHEREAS, the AIP of Pozorrubio has a total investment requirement amounting to P239,810,112.33, which will be funded from the municipality's 2021 Annual Budget which was enacted by their Sangguniang Bayan on December 14, 2020 through Appropriation Ordinance No. 05-12142020;

WHEREAS, the development fund amounting to P42,000,000.00 which is allocated for development projects is twenty percent (20%) of the municipality's IRA (P203,694,259.00) for CY 2021. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA are in conformity with DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 (*Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects*);

WHEREAS, the programs, projects and activities identified to be funded by the 5% LDRRM Fund of the municipality amounting to P12,000,000.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRM Plan shall be submitted to the Office of Civil Defense (OCD) for review provided under Item No. 2.2.12 of the Department of Budget and Management – Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found to be fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated July 6, 2020;
