APPROVING THE REALIGNMENT OF VARIOUS PROGRAMS/PROJECTS IN THE APPROVED ANNUAL INVESTMENT PROGRAM OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2022 TO AUGMENT FUNDING FOR THE COMMUNITY DEVELOPMENT PROJECTS AND MAINTENANCE AND OTHER OPERATING EXPENSES

WHEREAS, the Annual Investment Program for CY 2022 of the Province of Pangasinan was approved by the Sangguniang Panlalawigan through Provincial Resolution No. 936-2021 dated November 15, 2021;

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the realignment of various programs/projects in the approved Annual Investment Program of the Province of Pangasinan for Calendar Year 2022 to augment funding for the Community Development Projects and Maintenance and Other Operating Expenses as endorsed by the Provincial Development Council through PDC Execom Resolution No. 01-22;

WHEREAS, the realignment covers the following:

- Special Purpose Appropriations (Non Office) (by virtue of Executive Order No. 0002-2022, dated January 7, 2022) involving a total amount of P99,500,000.00, namely: Maintenance and Improvement of Provincial Buildings and Facilities (P10,000,000.00), Maintenance/Improvement of Various Hospitals (P5,000,000.00), Counterpart of Philhealth Premiums (P29,000,000.00), Umaani Festival (P3,500,000.00), Population Services Management Programs (P5,000,000.00), Corn/Rice Production Programs (P5,000,000.00), General Transportation Services (P2,000,000.00), Tourism Fund (P10,000,000.00), Counterpart for PRDP (P20,000,000.00),

Construction of Crematorium Phase I (P10,000,000.00), and 20% Development Fund 2021 (by virtue of Executive Order No. 0003-2022, dated January 7, 2022) involving a total amount of P152,000,000.00, namely: Housing Projects (P5,000,000.00), Irrigation (P10,000,000.00), Coastal Resources Management Projects (P2,000,000.00), Water River Resources Management Projects (P10,000,000.00), Construction, Repair and Maintenance of Various Roads and Bridges (P120,000,000.00), and Water and Illumination (P5,000,000.00).

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


