**RESOLUTION NO. 151-2021**

**APPROVING RESOLUTION NO. 2020-59 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "APPROVING ANNUAL SUPPLEMENTAL INVESTMENT PROGRAM NO. 2020-03 OF THE SUPPLEMENTAL BUDGET NO. 2020-03 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2020-59 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of San Manuel, Pangasinan had adopted and endorsed the municipality's Supplemental Investment Program No. 3 thru MDC Resolution No. 05, S-2020 dated December 4, 2020 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

**WHEREAS**, the Supplemental Investment Program No. 3 with an investment requirement amounting to P7,990,314.65 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of offices and implementation of development project in the municipality;

**WHEREAS**, on December 9, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 3 through Appropriation Ordinance No. 04, S-2020 to support the implementation of the Supplemental Investment Program No. 3;
