**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 1 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2022**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 1 of the Province of Pangasinan for Calendar Year 2022 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 02-22;

WHEREAS, Supplemental Investment Program No. 1 contains other priority programs, projects and activities that are not included in the approved 2022 Annual Investment Program of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program includes programs/projects proposed to be funded from the loan proceeds from the Development Bank of the Philippines; Payment of Interest on loan from the Development Bank of the Philippines; Community Development Projects to be funded from the realigned Development Fund and Special Purpose Appropriation (Non Office) CY 2022; various projects to be funded from Special Education Fund CY 2022; realignment from Capital Outlay to Other Maintenance and Other Operating Expenses for Legislative Services, and preparedness and mitigation project to be funded from the realigned Local Disaster Risk Reduction and Management Fund CY 2022;

WHEREAS, the said Supplemental Investment Program also includes details of Infrastructure and Capital Outlay of some offices of the Province funded from the Annual Budget 2022;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


WHEREAS, after careful study of the said Program, this august Body finds it to be in order;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


