PROVINCIAL ORDINANCE NO. 153-2011

AN ORDINANCE CHANGING THE NAMES OF UMINGAN MEDICARE HOSPITAL TO UMINGAN COMMUNITY HOSPITAL, ASINGAN MEDICARE HOSPITAL TO ASINGAN COMMUNITY HOSPITAL (SANTIAGO ABELLA GINEZ SR. MEMORIAL HOSPITAL), BOLINAO MEDICARE HOSPITAL TO BOLINAO COMMUNITY HOSPITAL, MAPANDAN MUNICIPAL HOSPITAL TO MAPANDAN COMMUNITY HOSPITAL, POZORRUBIO MUNICIPAL HOSPITAL TO POZORRUBIO COMMUNITY HOSPITAL, URDANETA GENERAL HOSPITAL (DON AMADEO J. PEREZ MEMORIAL GENERAL HOSPITAL) TO URDANETA DISTRICT HOSPITAL (DON AMADEO J. PEREZ MEMORIAL GENERAL HOSPITAL); AND PLACING THE NAME OF THE DECEASED DONOR AND/OR THE PERSONALITIES AFTER WHICH THESE HOSPITALS WERE NAMED IN THE FOLLOWING HOSPITALS: MANAOAG COMMUNITY HOSPITAL (DON EUGENIO PEREZ MEMORIAL HOSPITAL), DASOL COMMUNITY HOSPITAL (COL. DOMINGO A. VALDEZ MEMORIAL HOSPITAL), AND LINGAYEN DISTRICT HOSPITAL (DON MARIANO C. VERSOZA MEMORIAL HOSPITAL)

WHEREAS, this august Body was in receipt of a copy of Letter of Dr. Anna Maria Teresa S. de Guzman, Provincial Health Officer II, requesting the change of name of Umingan Medicare Hospital, Asingan Medicare Hospital, Bolinao Medicare Hospital, Mapandan Municipal Hospital, Pozorrubio Municipal Hospital and Urdaneta General Hospital (Don Amadeo J. Perez Memorial General Hospital) which are all provincial government hospitals;

WHEREAS, Executive Order No. 503 which provides for the rules and regulations implementing the transfers of personnel and assets, liabilities and records of National Government Agencies whose functions are to be devolved to the Local Government Units, there is indeed a need to change the names of the aforementioned hospitals for the purpose of appropriate uniformity, recognition, identification and all other legal intentions;

WHEREAS, Section 13 (4) of RA 7160, otherwise known as the Local Government Code of 1991, provides that:

Sec. 13. Naming of Local Government Units and Public Places, Streets and Structures. (a) The Sangguniang Panlalawigan may, in consultation with the Philippine Historical Commission (PHC), change the name of the following within its territorial jurisdiction:

x x x

(4) Provincial hospitals, health centers, and other health facilities; and

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded –

Be it enacted by the Sangguniang Panlalawigan in session assembled, that:

SECTION 1. The following names of the provincial government operated community and district hospitals are hereby changed, to wit:

From	To
1. Asingan Medicare Hospital	Asingan Community Hospital (Santiago Abella Ginez Sr. Memorial Hospital)
2. Bolinao Medicare Hospital	Bolinao Community Hospital
3. Umingan Medicare Hospital	Umingan Community Hospital
4. Mapandan Municipal Hospital	Mapandan Community Hospital
5. Pozorrubio Municipal Hospital	Pozorrubio Community Hospital
6. Urdaneta General Hospital (Don Amadeo J. Perez Memorial General Hospital)	Urdaneta District Hospital (Don Amadeo J. Perez Memorial General Hospital)

2. Dasol Community Hospital
(Col. Domingo A. Valdez Memorial Hospital)
3. Lingayen District Hospital
(Don Mariano C. Versoza Memorial Hospital)

SECTION 3. The Provincial Health Office and the Provincial Legal Office are tasked to undertake measures for the compliance of existing laws, rules and regulations for the proper implementation of this Ordinance.

SECTION 4. This ordinance shall take effect upon its approval.
