## **PROVINCIAL RESOLUTION NO. 154-2022**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF URBIZONDO, PANGASINAN FOR THE AVAILMENT OF THE SERVICES OF THE PANGASINAN MOLECULAR DIAGNOSTICS LABORATORY LOCATED AT THE PANGASINAN PROVINCIAL HOSPITAL**

**WHEREAS**, the Provincial Government of Pangasinan maintains the operation of the Pangasinan Molecular Diagnostics Laboratory located at the Pangasinan Provincial Hospital, San Carlos City, Pangasinan;

**WHEREAS**, with the molecular diagnostics laboratory operating in Pangasinan, it is capable of providing accurate and precise laboratory results including but not limited to RT-PCR test results for COVID-19 related cases for a shorter period of time;

**WHEREAS**, the Pangasinan Molecular Diagnostics Laboratory was established to cater to the needs of the people of Pangasinan and nearby localities for various COVID-19 related activities in order to help the country in the fight against the pandemic;

**WHEREAS**, the Municipality of Urbizondo, Pangasinan is interested in availing of the services of the Pangasinan Molecular Diagnostics Laboratory to have access to quality and affordable laboratory diagnostic services;

**WHEREAS**, the Municipality of Urbizondo, Pangasinan has agreed to pay the cost of testing in excess of the package amount under PhilHealth Circular No. 2021-0001 for COVID-19 testing by Realtime RT-PCR done by the molecular diagnostics laboratory for the constituents of the municipality;
