APPROVING SB RESOLUTION NO. 55, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE REALIGNMENT OF THREE MILLION PESOS (P3,000,000.00) FROM THE ANNUAL INVESTMENT PROGRAM CY 2021 FUNDED BY MDF 2021 FOR COVID RELATED PPAs”

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 55, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the proposed for realignment of appropriation for 20% development fund project in AIP 2021 to augment funding for Covid-19 related project of the LGU emanated from the Local Development Council and was endorsed to the Sangguniang Bayan through MDC Resolution No. 2021-08 on October 26, 2021;

WHEREAS, this Supplemental Investment Program covers fund augmentation for the Maintenance and Other Operating Expenses of some municipal offices and implementation of various COVID-19 related programs/projects, including the project to be funded from the realigned 20% development fund as contained in SB Resolution No. 55, S-2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;


