RESOLUTION NO. 158-2021

APPROVING SB RESOLUTION NO. 262-2020 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING THE CY 2021 ANNUAL INVESTMENT PROGRAM (AIP) OF MANGATAREM, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 262-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Mangatarem, Pangasinan had identified and prioritized programs and projects in the municipality’s Annual Investment Program for Calendar Year 2021. This was endorsed by the Local Development Council to the Sangguniang Bayan for approval on October 16, 2020 thru MDC Resolution No. 01, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Mangatarem, Pangasinan was formulated following the prescribed AIP Summary Form and covers: a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the

priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Local Disaster Risk Reduction and Management Fund Plan, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Gender and Development Plan, g) Annual Procurement Plan, h) Annual Cultural Development Plan, i) Nutrition Action Plan, and j) list of programs/projects/activities for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and PPAs to address the problem on illegal drugs;

WHEREAS, the proposed AIP of Mangatarem CY 2021 has a total investment requirement of P269,730,000.00. Funding support for the implementation of which is embodied in their proposed Annual Budget for CY 2021 in the amount of P269,730,090.00, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 04, S-2020 dated December 16, 2020;

WHEREAS, this is also in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P246,000,000.00), which is equivalent to P49,200,000.00 is allocated for development projects. These development projects are in conformity with Joint DBM-DOF-DILG Joint Memorandum Circular 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects);

WHEREAS, the Disaster Risk Reduction and Management Plan, in preparation for and to mitigate the impact of disasters, proposed to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P13,486,500.00 is in conformity to Section 21 of RA 10121. The proposed programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P9,440,550.00 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRM Plan of the municipality shall be submitted to the Office of the Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management – Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) of the municipality were reviewed by the Department of Interior and Local Government Provincial Office and were found to be fully compliant in form and in contents with the provisions of DBM-PCW-DILG-NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem;
