RESOLUTION NO. 162-2020

APPROVING RESOLUTION NO. 99, S-2019 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN/PROGRAM (AIP) (FUNDED BY THE 20% INTERNAL REVENUE ALLOTMENT AND OTHER SOURCES) OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2020"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 99, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Calasiao, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Local Development Council to the Sangguniang Bayan thru MDC Resolution No. 4, S-2019 dated September 20, 2019 and was favorably acted upon by the Sangguniang Bayan on November 11, 2019 thru SB Resolution No. 99, S-2019;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Calasiao, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, and d) activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) Programs/projects to be funded by External Sources, b) Local Climate Change Action Plan, c) Peace and Order Plan, d) list of programs/projects/activities (PPAs) for the Local Council for the Protection of Children, e) list of programs/projects/activities (PPAs) for Senior Citizens and Persons with Disabilities, f) list of programs/projects/activities (PPAs) to combat AIDS, g) Nutrition Action Plan and j) Annual Cultural Development Plan;

WHEREAS, the AIP of Calasiao for CY 2020 has a total investment requirement of P779,097,558.00. Of this, P287,477,634.00 will be financed by the LGU (P281,177,634.00 for General Fund Proper and P6,300,000.00 for Local Economic Enterprise) as embodied in their 2020 Annual Budget passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 6, S-2019 dated November 11, 2019. The remaining amount will be sourced from the national government agencies, provincial government, and loan from the Land Bank of the Philippines, and other sources;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P216,572,634.00) which is equivalent to P43,314,526.80 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the Municipal Disaster Risk Reduction and Management Investment Plan amounting to P13,932,381.70 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

WHEREAS, however, the LDRRM Plan of the municipality shall still be submitted to the Office of Civil Defense for review as per Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the Gender and Development Plan and Budget for CY 2019 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";
